Mr. Saïd Fazili is the Director for European Integration at the Dutch Ministry of Foreign Affairs. In his previous roles, he served as European Union adviser at the Prime Minister's Office at the Ministry of General Affairs and Deputy Director for the Middle East and North Africa at the Dutch MFA. Before that, he served for four years as Antici at the Permanent Representation of the Netherlands to the European Union. He previously held various other positions at the Ministry of Foreign Affairs, including Head of the Migration Task Force and Policy Coordinator at the European Integration Directorate.

Ms. Marie-Charlotte van Lamsweerde has worked as a Civil Servant in the General Secretariat of the Council (GSC) since 2011. A lawyer by training, she is currently a Senior Administrator, working on EU internal reforms in view of a future enlargement (DG for General and Institutional Policy). In other functions, she worked as a member of the Common Secretariat of the Conference on the Future of Europe (2021-2022), on interinstitutional relations and health policy. From 2001 to 2011, she was an official at the European Commission.






Mr. Maarten Lemstra is a Press & Strategic Communication Officer at the European Commission's Directorate-General for Enlargement and the Eastern Neighbourhood (DG ENEST). As part of the Strategic Coordination and Communication unit at DG ENEST, he works on communication and outreach and engagement activities related to EU enlargement, both horizontally and with a focus on the Western Balkans. Before this, he also worked at the strategic advisory firm Global Counsel, where he conducted research on EU policy and political developments, and he was also a research assistant at the EU & Global Affairs unit of the Clingendael Institute, where he focused on EU external affairs. He holds a double MA/MSc in European Governance from the Universities of Utrecht and Konstanz as well as a BA in International Relations and International Organisation from the University of Groningen.

Prof. Dr. Hylke Dijkstra is a Professor of International Security and Cooperation at Maastricht University. He is the Editor-in-Chief of the journal Contemporary Security Policy, and a member of the Board of the Dutch Political Science Association, and the Advisory Council of the Netherlands Institute of Governance. He has received six large EU grants. Notably, he was the Principal Investigator of an ERC research project (2019-2024) on the decline and death of international organizations. He is the winner of the 2008 prize for best article in the European Foreign Affairs Review for scholars under 35. He received the Otto von der Gablentz Academic Prize and the G.A. Van Poelje Prize. Dijkstra is widely published. Hylke Dijkstra holds a PhD in Political Science (cum laude) from Maastricht University.







Ms. Marijana Petrović is a Policy Analyst and Team Leader at the OECD Global Relations and Cooperation Directorate. In her current role, she provides analytical and capacity-building support on competitiveness and private sector development to OECD partner countries.
