- 3. Content and educational objectives
- a. Content

The European Union (EU) has grown from a community of 6 Member States to a Union of now 27 Member States. With each subsequent enlargement, the EU has faced questions of the growing political, cultural, and economic divide between Member States. The EU enlargement has been a complex multi-step interaction and multi-dimensional transformation process, involving different actors (the EU, the Member States, and the applicants) with diverse logic of rational or normative action that persists or changes over time and thus determining the different degrees and the formal institutionalization of horizontal integration (accession, association, or exclusion).

This course combines academic discussion with real-world insights on the EU enlargement. It examines the nature, dynamics, and impact of EU enlargement on the EU itself and candidate Member States. In doing so, it looks into the role of the EU as a normative soft-power actor

and the legal framework governing the EU enlargement, its interaction with and the effects in the third States. The course adopts an interdisciplinary approach by combining perspectives of legal studies and political science. We will specifically discuss the conceptual and theoretical framework of EU enlargement and Europeanization with a particular focus on the motivations and explanations associated with them, the EU enlargement process and compliance with EU acquis by the candidate countries emphasizing the main dilemmas and their implications, and EU enlargement and rule of law with an emphasis on Western Balkans.

## b. Educational objectives

- To understand the development of EU enlargement policy, its legal foundations and the current political debates around it.
- To familiarize students with the analytical and theoretical framework of EU Enlargement and Europeanization.
- To identify the state of play and challenges in the current EU enlargement policy and its impact.
- To provide students with the analytical tools to critically think about the EU's role, its political objectives and policy mechanism towards EU enlargement dilemmas and deadlocks.

#### c. Evaluation

Evaluation of academic education starts at the beginning of a course and is a continuous dialogue between students and lecturers. Writing a literature review: 30% of the final grade

Research paper: 70% of the final grade

### 2. Research paper Deadline: 26 March 2025, 09:00 AM CET

Students should also write a research paper (from now on referred to as 'paper') on one of the topics published on Canvas. Detailed instructions for writing the paper can be found on Canvas page. The paper may focus on one of the suggested topics published on Canvas.

However, students are also free to explore a different aspect of Europeanisation and EU enlargement that is not directly covered in the course or to engage with a less contemporary subject.

Length: Up to 3000 words (excluding title page and references), Times New Roman, Font 12, Line spacing 1,5. No 10% margin applies. If students exceed the word limit, the grade will be lowered by 0.5 point. The paper must be the result of the original and individual work of the student—the presumption of fraud results in a grading of 0.

#### d. Assessment and weighting

The final grade is calculated based on the respective weight of the literature review counting for 30% of the final grade and research paper counting for the 70% of the final grade. The final grade will be rounded to the nearest decimal point.

Test results lapse after the end of the semester in which the final mark was awarded. If a student does not complete a course that is a compulsory part of their degree programme in one semester, they will have to retake the course at a later opportunity.

#### e. Results

The results will be posted on Canvas no more than 15 working days after the exam (and at least 5 working days before the re-sit).

#### f. Feedback and inspection

As both submissions will be graded on canvas, you will be able to see the grading and comments on Canvas. Should you require further feedback, please do not hesitate to reach out the course instructor.

### g. Resit

For the resit, students may submit a 3,000-word research paper (excluding the title page and references; the 10% margin does not apply) on a topic not covered in the initial literature review or the original research paper. After submitting the resit research paper, please notify the lecturers no later than two working days after the submission.

Week 1 Lecture: 10 February 2025 (Dr. Zamira Xhaferri)

Introduction to the Course & The legal Dimension of EU Enlargement

In the course of EU enlargement, the EU has already become increasingly heterogeneous but if heterogeneity results in such different interests that consensus on necessary measures can no longer be reached within the framework of European policies, then the EU, trapped in a resulting inability to act, falls into a state of "imperial overstretch" that threatens its existence. This lecture outlines the role of the EU as a global actor and the legal framework governing the external relations of the EU and the enlargement process more specifically. It takes a bottom-up approach to critically examine the current legal framework and open us the debate for Treaty changes.

Week 1 Seminar: 14 February 2025 (Dr. Zamira Xhaferri)

In this seminar, students will discuss critical questions of the opening and widening of the EU. The focus will be on (i) options for Treaty change, (ii) differentiation, and (iii) managing the enlargement process. Students will be divided into groups to identify and analyze key issues related to the seminar themes, engaging in discussions, applying theoretical frameworks, and exploring practical implications. Each group will present their findings, fostering peer feedback, critical thinking, and interactive learning.

We will investigate the process of EU-driven change in the political and economic systems of acceding countries, focusing on the specific mechanisms and conditions that facilitate this process. Additionally, we will analyze how these changes impact domestic politics and policies. By providing a conceptual and theoretical framework, this lecture aims to enhance your understanding of the EU's approach to enlargement, its key mechanisms, and the most significant conditions in this context.

Week 3 Lecture: 24 February 2025 (Dr. Dorian Jano)

EU enlargement and Europeanization on the Western Balkans

This lecture will focus on the EU enlargement in the Western Balkans. The module will begin with an overview of post-communist transformations in the Balkan region, followed by a critical assessment of EU strategies and policies applied to the Western Balkans since the fall of communism, with a particular emphasis on the current Enlargement approach. We will also discuss the EU and national instruments used for adapting and implementing the EU acquis into domestic legislation, supported by empirical data and case studies of candidate countries' performance in adopting and implementing EU laws.

Week 3 Seminar: 28 February 2025 (dr. Dorian Jano)

The European Commission assesses 33 policy areas annually for all candidate countries aspiring to join the EU. These assessments are crucial for Europeanisation, as countries must be prepared in all these sectors to successfully close accession negotiations and become EU member states. The seminar will aim to understand what it means to "meet EU standards" and how we can understand and make the Commission reports "readable."

Week 4 Lecture: 3 March 2025 (Guest speaker, H.E. Ambassador Mr. Almir Šahović,

Ambassador of Bosnia and Herzegovina to the Kingdom of the Netherlands) Bosnia and Herzegovina on the Path to EU Membership: Challenges, Opportunities, and the Road Ahead

The guest lecture by the Ambassador of Bosnia and Herzegovina will provide an insightful overview of the country's recent history, institutional framework, and its path toward European Union integration. It will begin with a discussion on the war from 1992 to 1995 and the Dayton Agreement, which will be explained as the foundation of Bosnia and Herzegovina's constitutional structure. The lecture will then explore the country's anticipated progress toward EU membership, covering key milestones such as the Stabilisation and Association Agreement, its potential candidate and official candidate status, and the decision to open accession negotiations. Technical aspects of EU integration, particularly alignment with the acquis communautaire, will be highlighted alongside geopolitical considerations and the broader regional dynamics of the Western Balkans. The speaker will also address the Netherlands' position on EU enlargement and whether Bosnia and Herzegovina could accelerate its accession process. Finally, the lecture will outline the main obstacles to EU membership, including political and legal challenges, and discuss potential future developments that could shape the country's integration prospects.

#### BIO of Guest Speaker

H.E. Ambassador Almir Šahović is a seasoned diplomat specializing in EU enlargement and Western Balkans integration. As the Ambassador of Bosnia and Herzegovina to the Netherlands and Portugal and Permanent Representative to the OPCW, he plays a key role in representing his country's interests on the international stage. With a Law degree from the University of Sarajevo and a master's in European studies from the College of Europe in Bruges, he has a strong academic foundation in European integration and multilateral governance. Throughout his career in the Ministry of Foreign Affairs, he has held key positions, including Assistant Minister for Multilateral Relations and Political Director, where he was actively involved in EU accession processes, regional cooperation, and institutional reforms in the Western Balkans. As Ambassador to France, Algeria, Monaco, and Andorra, and Permanent Representative to UNESCO, the OIF, and the Council of Europe, he has worked extensively on Bosnia and Herzegovina's EU integration efforts, advocating for alignment with EU policies, democratic reforms, and regional stability. His leadership as Chair of the Committee of Ministers of the Council of Europe (2015) further reinforced his engagement in rule of law, human rights, and governance reforms critical to the EU accession path. On 29 November 2024, he was elected Chairperson of the OPCW's 29th Conference of the States Parties, demonstrating his expertise in multilateral diplomacy and global governance. With extensive experience in EU enlargement policy, institutional reform, and regional diplomacy, Šahović remains a key advocate for the Western Balkans' integration into the European Union.

Week 4 Seminar: 7 March 2025 (dr. Zamira Xhaferri)

This seminar will explore Bosnia and Herzegovina's path to EU membership, focusing on

key legal, political, and geopolitical challenges. We will discuss the impact of the Dayton Agreement on governance, the country's progress from potential candidate to official candidate status, and the EU's decision to open accession negotiations (European Commission, 2024). Key topics include (i)Institutional and constitutional challenges to EU reforms (Bajramović, 2024); (ii)Legal and technical hurdles in aligning with EU standards (Kovačević & Stanić, 2024); The geopolitical role of the Western Balkans and the Netherlands' stance on enlargement (Council of the EU, 2024). By the end, participants will gain insights into Bosnia and Herzegovina's EU future and the obstacles it must overcome.

Week 5 Lecture: 10 March 2025 (guest speaker, dr. Serban Brebenel)

The Accession of Ukraine to the EU: Challenges, Opportunities, and the Evolving Enlargement Process

The discussion will focus on the current state of Ukraine's negotiations, examining the political and legal decisions that have influenced its candidacy. It will assess the broader implications of Ukraine's potential membership for both the EU and Ukraine, including the benefits, challenges, and institutional reforms required for integration. The session will also address the internal adjustments the EU must undertake to accommodate Ukraine, considering governance, financial, and policymaking aspects.

#### BIO of Guest Speaker

Dr. Serban Brebenel has been a distinguished member of the Romanian diplomatic corps since 2004. With extensive experience in European and international affairs, he currently serves as the Principal Desk Officer for EU-Türkiye relations at the European External Action Service (EEAS). Over the course of his career, Dr. Brebenel has held various diplomatic and policy-making positions in both Bucharest and Washington, D.C. Since 2015, he has been actively engaged with EU institutions in Brussels in different capacities, including serving as a COELA (Council Working Party on Enlargement and Countries Negotiating Accession to the EU) delegate. Notably, during Romania's Presidency of the Council of the EU in 2019, he played a crucial role as the country's Head of the Brexit Task Force, contributing to the EU's negotiations and policy coordination efforts. Dr. Brebenel holds a Ph.D. in European Studies from the University of Amsterdam, reflecting his deep academic engagement with European integration and governance. He also earned both a Master's and a Bachelor's degree in International Affairs from the Faculty of International Relations at the Academy of Economic Studies in Bucharest, Romania. His expertise in EU affairs, diplomacy, and international relations makes him a highly regarded professional in his field.

## Week 5 Seminar: 14 March 2025 (dr. Zamira Xhaferri)

In this seminar, students will engage in group-based discussions and problem-solving exercises to explore the challenges and opportunities of Ukraine's EU accession. Using insights from Bendarzsevszkij (2025) and Kazdobina et al. (2024), they will analyze policy scenarios, assess Ukraine's preparedness for membership, and evaluate the EU's capacity to integrate Ukraine. Through collaborative discussions, students will critically examine key issues such as governance reforms, economic alignment, and security cooperation.
