RE-THINKING EU ENLARGEMENT

►►► In rethinking EU enlargement, we open the debate on 'security/stability through democracy' or 'democracy through security/stability'. Should EU enlargement be informed by a short-term perspective of geostrategic calculations, or should it be based on a more profound long-term community-building process? What mechanism - policy tools are needed to have a credible EU enlargement policy with a realistic accession perspective and substantial democratic changes that will enhance Europe's at large 'collective security' and 'democratic prosperity' (rule of law, respect for EU values and fundamental rights) which are both cornerstones, anchors, and engines of fostering the European integration in solid peace/stability and democracy. Such double-headed policy is key for the (Enlarged) European Union - especially during heightened geopolitical competition and democratic backsliding. How the EU (including its Member States) and the candidate countries will respond to the strains resulting from such an EU enlargement dilemma, and what trade-offs will have to be made to reconcile the tensions

Zamira Xhaferri is a Lecturer in European Law at the Department of European Studies, Faculty of Humanities, University of Amsterdam and an active research member of the Amsterdam School for Regional, Transnational and European Studies (ARTES) and Amsterdam Center for European Studies (ACES). Her research interests include EU institutional law, EU administrative law, comitology, enlargement and external relations of the EU, food safety and access to justice in environmental matters. Previously, he has been a Marie Curie fellow at the Centre for South-East European Studies at the University of Graz, a visiting scholar at the Clinton School of Public Service at the University of Arkansas (USA), and a research fellow at the Institute for European Integration (Europa-Kolleg in Hamburg), and the Institute for Advanced Studies (Collegium Budapest).

Frank Schimmelfennig is a Professor of European Politics and a member of the Center for Comparative and International Studies at ETH Zurich. He is also a member of the Swiss National Research Council, an Associate of the Robert Schuman Centre for Advanced Studies at the European University Institute, Chairman of the Scientific Board of Institut für Europäische Politik Berlin and a member of the Board of the Trans-European Policy Studies Association.

Adam Lazowski is a Professor of EU law at the University of Westminster and a Visiting Professor at the College of Europe (Natolin) and Ivan Franko National University in Lviv (Ukraine). His research focuses on EU pre-accession policy, EU External Relations, Internal Market, EU Criminal Law, and withdrawal from the European Union. He obtained his PhD from the University of Warsaw, where he lectured between 1999 and 2003, followed by a senior research position in European law at the T.M.C. Asser Institute (The Hague).

Andrea Ott is a Professor of EU External Relations Law at the Law Faculty of Maastricht University. She regularly teaches EU institutional law, EU external relations, Enlargement and WTO law in the Netherlands, Central and Eastern Europe, Southeast Asia and China. She is a member of the editorial committee of the Maastricht Journal of European and Comparative Law and a Member of the board of Centre of EU External Relations Law. Since 2011, she holds a Jean Monnet Chair in EU law at Maastricht University, is co-director of Centre for European Research in Maastricht, and a scholar at the Maastricht Centre for European Law.

Gergana Noutcheva is Associate Professor in International Relations and European Foreign Policy at the Political Science Department of Maastricht University, The Netherlands. She holds a PhD in International Relations from the University of Pittsburgh, USA (2006). Her research focuses on comparative democratization in the Balkans and the post-Soviet space. Her articles have appeared in the Journal of Common Market Studies, Journal of European Public Policy, West European Politics, East European Politics and Societies, Journal of European Integration, Democratization, International Spectator, Geopolitics. Prior

to joining Maastricht University, she was Research Fellow at the Centre for European Policy Studies in Brussels (2002-2006) where she published a number of policy reports and briefs on the EU enlargement policy and the European Neighborhood Policy.

Elena Basheska is a Post-doctoral Research Fellow at CEU Democracy Institute in Budapest. Her research interests focus on EU enlargement, EU external relations, the rule of law, citizenship matters, and the protection of human rights. She has extensive experience as a researcher, working in various sectors (including academia, NGOs, law firms and professional organisations), as well as an independent consultant. Ebru Turhan is an Associate Professor of European Studies at the Department of Political Science and International Relations at the Turkish-German University in Istanbul.
